## Burtchville Township Board of Trustees Regular Meeting April 24, 2023

**1.** The Regular Meeting of the Burtchville Township Board of Trustees was called to order at 7:00 p.m. by Supervisor Appel. Pledge of Allegiance was followed by roll call.

- **2. Consent Agenda:** Minutes of Regular Meeting on March 20, 2023 and Special meeting on April 11, 2023. Listing of invoices for post approval of \$61,068.49 for April 3, 2023 and \$46,350.62 for April 13, 2023 and pre-approval of \$6,395.93 for April 25, 2023 with a monthly total of \$113,815.04. Motion by Minnie supported by Bailey to approve the consent agenda. Roll call: ayes: Minnie, Bailey, Janks, Briolat, and Appel. Nays: none. Motion carries.
- **3. Citizens wishing to address the Board of Trustees:** Curtis Trudeau of 4078 Harris Road asked the Board for an update to water district # 3. Appel responded that grants have been applied for with results not known until October of 2023. If grants are received, depending on how much the grants are for, it is possible to complete the entire project. Appel continued, as soon as the Board knows we will hold a meeting to inform all the residents involved. Trudeau was satisfied with the response.
