RESOLUTION INDEMNIFYING AND HOLDING HARMLESS THE ST. CLAIR COUNTY ROAD COMMISSION IN CONSIDERATION OF ANNUAL PERMIT BEING ISSUED TO TOWNSHIP OF BURTCHVILLE

WHEREAS, the Township of Burtchville, in the County of St Clair, Michigan, desires to make public improvements; namely mowing and also cuffing of small trees in ditches thereto, which requires certain operations within and upon the right-of-way of County highways known as all local, primary and county roads, which are under the jurisdiction of the St Clair County Board of County Road Commissioners; herein after "the Board of County Road Commissioners".

WHEREAS, the Board of County Road Commissioners is willing to issue a permit, therefore, provided the said Board of County Road Commissioners is assured of indemnity and protection against all liability arising by reason of Michigan Law;

NOW, THEREFORE, BE it RESOLVED by the governing Board of the for Township of Burtchville, St Clair County, Michigan, that in consideration of the Board of County Road Commissioners granting a permit to the Township of Burtchville upon proper application therefore, to operate and maintain a water distribution system and appurtenances thereto along and upon the right-of-way of certain highways of the Township of Burtchville, shall save harmless and indemnify the County of St Clair and Board of County Road Commissioners, and their successors, against all liability which arises or which might arise either during operation or during maintenance of the water distribution system along St Clair County Highways.
