Sealed bids for the Lakeshore Road Sheldon Beach Subdivision Paving Project 2025 will be received by the Burtchville Township, Michigan, at the office of Burtchville Township, 4000 Burtch Road, Burtchville Township, Michigan, 48059 until 10:00am, prevailing local time on Wednesday, February 4th, 2026. The bids will be publicly opened and read aloud immediately thereafter for the construction of Lakeshore Road Sheldon Beach Subdivision Paving Project 2025.

The work shall consist of furnishing all labor, material, and equipment required to remove 3185 syd of existing asphalt surface, mill 3020 syd of asphalt surface, install 3450 tons of hot mix asphalt pavement, 292 cyd of aggregate shoulder, 2745 syd of concrete driveway, 910 syd of hot mix asphalt driveway, lawn restoration, temporary traffic control and other incidental related items.

The right is reserved by OWNER to accept any Bid, to reject any Bid, and to waive irregularities in Bids. The successful bidder will be required to furnish satisfactory Performance, Labor and Materials bonds, Maintenance and Guarantee bonds, and insurance certificates.

Bids may not be withdrawn for 90 days after receipt. All bids must be submitted on the Proposal Forms provided by the Engineer.
